1. EU APPLICANTS FOR ACADEMIC AND PREPARATORY COURSES

1.a. How to apply

Applications have to be submitted through ISIDATA portal only.

1.b. Deadlines

Summer term: 03/04/2023 – 06/05/2023

Autumn term: 04/07/2023 - 26/07/2023 (such term will be open for remaining positions only).

Admission exams of Music therapy, Jazz (Electric bass, Percussions, Voice, Guitar, Double bass, Piano, Sax, Trumpet and Trombone) and Electronic music will exclusively take place in **September**.

Accademici:

- Candidate's **ID or passport** (along with one parent's id card or passport copy for underage applicants).
- Candidate's **degree** (school-leaving certificate/graduation) or "dichiarazione sostitutiva" <https://www.conservatorioverona.it/it/didattica/modulistica/>.
NOTE: Students currently attending a **High School** can apply under reserve; applicants need to commit themselves to complete EQF4 education level before taking 1st cycle final exam by using "dichiarazione sostitutiva" form.
Conditional applications are accepted for students who will graduate during the next examination sessions.

- FOREIGN APPLICANTS ONLY: **B2 Italian language knowledge** is compulsory. All applicants will have to take a language test, unless in possession of a B2 certification issued by institutions authorized by the Italian Government.

Foreign degrees will have to be proved by:

- "dichiarazione di valore in loco" issued by the Italian embassies;
- or diploma supplement <https://www.conservatorioverona.it/it/international/international/> ;
- or "attestato di comparabilità" issued by Cimea <http://www.cimea.it/it/index.aspx> ;

Admitted applicants, once enrolled will have to ask for the registration in the Italian municipality where they intend to establish their residence (d.l. 6/02/07 n.30).

2. NON-EU APPLICANTS FOR ACADEMIC COURSES

2.1 INTERNATIONAL ALLOTMENT

NON-EU applicants, who permanently live in an European country, can directly apply to our conservatory **ONLY IF** in possession of a regular visa "**permesso di soggiorno**" for work/family/refugee/ect. reasons or whether the applicant has already obtained a school leaving certification, recognized by the Italian Government (see point 1).

If a new study visa is necessary, applicants must register themselves from 03/04/2023 to 20/07/2023 through UNIVERSITALY.

Examinations will exclusively take place in September 2023 (distance modality). **B2 Italian language knowledge** is compulsory. All applicants will have to take a language test, unless in possession of a B2 certification issued by institutions authorized by the Italian Government.

Foreign degrees will have to be proved by:

- "dichiarazione di valore in loco" issued by the Italian embassies;
- or "attestato di comparabilità" issued by Cimea <http://www.cimea.it/it/index.aspx>

3. CHINESE APPLICANTS - TURANDOT PROGRAMME

3.1 How to apply

APPLICANTS REGISTERED IN UNIVERSITALY IN 2022: students who selected Conservatorio of Verona will have to take a physical entry exam in September 2023; those who applied in other conservatories will not be accepted.

A **B2 Italian language knowledge** is compulsory. All applicants will have to take a language test, unless in possession of a B2 certification issued by institutions authorized by the Italian Government.

It is necessary to register in ISIDATA too (see 3.2).

APPLICATIONS FOR 2023.24: it is necessary to apply to University from 03/04/2023 to 20/07/2023. Do not register in Isidata: such enrollment will be necessary in 2024.
